



# Coleman County Electric Cooperative Scholarship Award



## **Purpose**

The Coleman County Electric Cooperative provides financial assistance for qualified individuals who are seeking an institution of higher education.

## **Eligibility**

The scholarship is available to 2019 high school graduates who will be attending a college, technical school, or university as a freshman. Other qualifications are; you must be a child of a member, a grandchild of a member, or child of a legal guardian who is a member of Coleman County Electric Cooperative. The applicant must reside with the active member whose residence is served by Coleman County Electric Cooperative.

## **The Application**

Applications are available at Coleman County Electric Cooperative, Inc; located at 3300 N Hwy 84 Coleman, Texas 76834 or you may print it from our web site at [www.colemanelectric.org](http://www.colemanelectric.org). The application must be typed or printed and completed in its entirety. The application must be signed and dated by both the student and parent or legal guardian. A billfold size picture must be included with the application. All applications must be mailed to P.O. ## **The Drawing**

A drawing will choose the eligible applicants, to be held in July at the cooperative's annual meeting. There will be seven separate drawings, one for each of the seven director districts of the Cooperative's service area. The approved applicant will then be designated to their correct district by the Cooperative.

## **The Scholarship**

The scholarship is \$1,000.00 payable to the qualifying college, technical school, or university. The winner of the scholarship must be registered as a full-time student and provide the cooperative with the name, address, phone number, and student identification number of the institution they are going to
