Purpose: The Coleman County Electric Cooperative provides financial assistance for qualified individuals who are seeking an institution of higher education.

Eligibility: This scholarship is available to 2023 high school graduates who will be attending a college, technical school, or university as a freshman. You must be a child of a member, a grandchild of a member, or child of a legal guardian who is a member of Coleman County Electric Cooperative. The applicant must reside with the active member whose residence is served by Coleman County Electric Cooperative.

Applications are available on our website and at our office, located at 3300 N Hwy 84 Coleman, Texas 76834. The application must be signed and dated by both the student and parent/legal guardian. A head-shot photo (no selfies), along with your application, will need to be submitted on our website, emailed to becca@colemanelectric.org or mailed into the CCEC office. All applications must be submitted no later than **April 7th, 2023. Contact Becca O'Leary at 325-625-2128 for any questions concerning the application.**

Selection of Winners: Eligible applicants will be designated to their correct district by the Cooperative. Each application will be reviewed by the Board of Directors. One applicant from each district will be selected as a recipient of the scholarship.

The scholarship is **\$1,500.00** payable to the qualifying college, technical school, or university. The winner of the scholarship must show proof of being registered as a full-time student and provide the cooperative with the name, address, phone number, and student identification number of the institution they are going to attend.
